a) CVSG Pavillion- Work Group to update on progress

Working Group gave an update:

- Taken into account all recommendations from the External Auditor and acted on all
- Re-written a new Tender Document with clearer boundaries and accountabilities
- Architect is reviewing split of work to confirm proposal is accurate financially
- Consultations RN has already received 123 positive replies from the Public regarding progressing the Project to reality. A Public meeting is arranged at Condover VH on Sat 23/11/24 10:00-12:00
- A complete Risk assessment has been carried out and a full document produced
- Reminder Auditor stated there were no financial concerns whatsoever to fund the project
- Contingency had been agreed by CPC previously, to the value of £10k, to come strictly from Brook Close Legacy Fund, and only if it is required at all
- The new Specification has been broken down to show CPC accountability Phase 2 only of a 6 Phase Project
- Tender document is the industry-recognised JCT contract
- All documentation to be be sent on or by Wed 20th November 2024 to all Cllr's to review
- An EPM to be held on Wed 27th November 2024 in order to action the Tender Document online

c) Condover

Woodland Park – PG updated Cllr's on:

- a quote received for a new Zip-Wire for £13,800. It was pointed out this quote had not been requested by CPC, and needed to be addressed to CWP Committee only. PG advised they may need to look for a Community Grant.
- Drainage for the Path had been completed.
- Trees Dave Williams had trimmed out dead wood. However, 3 trees need intervention, 2 with big boughs to lop, and the third tree, which is large, has a big split. This will require a quote for this work which will not be cheap. PG to ask Woodland Trust and/or The Forestry Commission for grants.

RB suggested it may not be financially viable for CPC to continue to fund CWP due to escalating costs as the trees get larger and larger, and the bills become increasingly more expensive. He suggested it may be better to relocate Play Equipment to another safer area, such as the CVSG.
