COMMUNITY GRANT SCHEME

INTRODUCTION

Subject to annual review, the Parish Council will provide funding for community groups/ organisations each year. In order to manage increased costs and reduced overall income, for 2025-26, the Parish Council has a **maximum grant ceiling of £500**. There is now just one form for all Community Grants.

Grant applications must comply with prevailing local government legislation and/or provide direct benefit to the parish and its community. The Council does not make grants to individuals, private companies or national charities.

COMMUNITY GRANTS SCHEME: up to and including £500

What can Community Grant be used for:

Community Grant funding can be used for a range of purposes which can be shown to help deliver the Parish Council's strategic priorities and be of direct benefit to the community. This may include:

- The cost of room hire for an event,
- Purchase of small equipment items
- Hire of equipment for a community event
- The cost of materials where these cannot recouped through contributions from participants
- Help towards start-up costs for a new community group or activity
- Help towards specialist professional fees for example a speaker for an event, an
 instructor or teacher, a facilitator for an environmental event A contribution
 towards a community trip or outing

This list is not exhaustive.

The Council's priorities include:

- Providing opportunities for young people (under 18 years) and older people to be more involved with community life
- Promoting sustainable living through reduction of waste and increased recycling
- Encouraging understanding and appreciation of the natural environment
- Encouraging and enabling better access to and enjoyment of the countryside
- Promoting and supporting healthier life-styles through physical activity, walking and cycling, and eating well

Community Grant can be used as matched funding, provided the overall scheme delivers the Parish Council's strategic priorities.

How to Apply

Application forms must be completed by the stated deadline. To be fair to all we cannot accept late applications unless there are exceptional circumstances. However there may be insufficient funding available to finance the application.

The Council aims to provide a prompt decision on your application

Successful applicants must be prepared to participate in any publicity requested by the Council.

The Council may require feedback on the benefits arising from the grant.

Other prospective funding sources must also be identified.

Applications will be assessed to ensure compliance with the objectives of the Council, namely to assist local clubs, societies and organisations to develop and achieve direct benefits to the local community.

The application must include your most recent audited accounts and constitution. No application will be considered without supporting financial information. The Council may wish to see evidence of investigation into alternative funding sources and details of matched funding.
